Materials stored in their original packaging in a clean, dry environment and protected against sunlight will neither show decrease of molecular weight nor chemical reactions. Therefore, there is no loss in original quality of the material. The materials are dried in the factory to a specified maximum moisture content and delivered in packaging materials that prevent, but may not completely exclude, moisture absorption. It is therefore recommended to conduct a visual inspection of the packaging according to your own standards two years after delivery, at the latest.
