Therefore, there is no loss in original quality of the material. The materials are dried in the factory to a specified maximum moisture content and delivered in packaging materials that prevent, but may not completely exclude, moisture absorption. It is therefore recommended to conduct a visual inspection of the packaging according to your own standards two years after delivery, at the latest.
